



**TV Giveaway Official Rules**  
(listed as Terms and Conditions on postcard)

1. **No purchase necessary to enter and win. Purchase will not improve chances of winning. Odds of winning depend on number of entries received.** Only members of Sabine Federal Credit Union in good standing and other persons within the credit union's field of membership age 18 and older are eligible to participate. Officials and employees of the credit union and their family members are not eligible. There will be one drawing for one television prize with an approximate retail value of \$500.
2. Eligible persons may enter the drawing by the following methods:
  - You will be provided with an opportunity to enter into the drawing each time you obtain any one or more of the following credit union services between June 15, 2009 and August 14, 2009: (i) VISA® Check Card, (ii) MasterCard® Credit Card, (iii) Any Consumer or Real Estate Loan, (iv) E-Statements, and (v) Online Bill Pay. Credit union membership is required to obtain credit union services.
  - To enter without purchase or obligation, submit an original handwritten 3" x 5" card with your name, address, member account number, if applicable, telephone number, and date of birth to TV Giveaway, Sabine Federal Credit Union, Attn: Marketing Dept., P.O. Box 3000, Orange, TX 77631. The credit union assumes no responsibility for lost, late, incomplete, stolen, misdirected, illegible, or postage-due mail entries. Entries must be received by the close of business on August 14, 2009.

Regardless of the entry method, there is a limit of five entries per person.

3. One prize consisting of a 32" High Definition LCD Television will be awarded in a random drawing from all eligible entries. Winner is responsible for any additional equipment and programming necessary to view high definition content. The drawing will be held at the credit union's home offices on or around August 18, 2009. Need not be present to win. All decisions are in the sole and absolute discretion of the credit union. Winner will be notified by telephone or U.S. mail. Prize is non-transferable, non-assignable, and may not be substituted. The credit union reserves the right to draw for an alternate winner if the winner cannot be contacted and awarded the prize within 30 days of the drawing.
4. **All entrants hereby release and hold harmless Sabine Federal Credit Union and its directors, officers, employees, and agents from and against any and all claims and liabilities arising out of any injuries, losses, or damages of any kind, including death and loss of or damage to property, that may be caused or alleged to be caused, in whole or in part, directly or indirectly, by participation in this drawing or by acceptance, possession, use, or misuse of the prize.**
5. Winner may be required to provide identification and additional documentation to receive prize, including winner's taxpayer identification number. The value of the prize may be considered income and reported to the Internal Revenue Service. Any applicable taxes are the sole responsibility of the prize winner.
6. By accepting prize, the winner grants the credit union the right to use his or her name and photograph for promotional purposes.
7. By entering the drawing, all participants accept and agree to be bound by these Official Rules. Any violation or non-compliance with these rules will result in disqualification.
